The meeting was called to order at 1:15 p.m.

No parliamentarian was appointed.

Rosalie Burkhead moved and Bud Davis seconded a motion to accept the minutes as written. Motion carried on a voice vote.

Treasurer's Report: Allen Glessner submitted his report (Attachment A).

Allen noted that the pink and yellow sheets are replacements from the previous report.

Scott Riegelhaupt-Herzig moved and Jim Davis seconded to submit the Treasurer's Report to audit. Motion carried on a voice vote.

President's Report: Barry Binge reported that their primary activities since the last meeting were the Jubilee and recruiting of additional potential Board members.

We danced at Stanford Quads, Top Cats, the Central Coast Square Affair in Santa Maria, and the SCVSDA's 48th Annual Jubilee at Blackford High School in San Jose.

Jim is in discussions with Joe Gill, Harker's Assistant Head of School, Non-Academic Affairs, for the possible use of the Blackford campus for the 49th and 50th Annual Jubilees. They are willing to consider our proposal the first week in December.

Sue is finishing up her 10th year as a director on the SCVSDA board; she wishes the Association all the best in the future and hopes to see everyone in a square soon.

Jim asked whether his mandate as the Facilities Procurement Committee included finding sites for multiple future years - for example, can he discuss 2006 as well as 2005? Barry Binge said yes.

After this report a discussion ensued about why very few are willing to serve on the Board this year, what it means for the association, and how we might change the meetings to make them more effective. Two proposed approaches are being developed, one by Jim Davis focussing on the structure of the meeting agendas, and another by Joe Dehn, focussing on merging the two meetings, and they will report back to the delegates at the next delegates meeting.

Second Vice President's report (Scott Riegelhaupt-Herzig): Activities report not provided in written or electronic form. The SCVSDA Holiday Parade application was accepted, and Ruth Riegelhaupt-Herzig is in the process of recruiting a caller. Scott mentioned that he felt that the Whing Ding contract was more favorable to the SCVCA than to the SCVSDA and a discussion ensued. Jim Davis asked that whoever send out the notice of the next delegates meeting please ask the delegates to bring the name and address of their club Presidents so they can be invited to the President's Ball.
